7. in the event of undisclosed illnesses or dangerous behavior being discovered, the "Rieshof Dogresort" reserves the right to terminate the contract immediately and, if necessary, take legal action for compensation.
8. the "Rieshof Dogresort" has full-time veterinary care available.
9. the "Rieshof Dogresort" does not assume responsibility for any damages to personal belongings of the animal (such as pillows, sweaters, toys, blankets, leash, etc.) and cannot be held liable for events that are beyond its control and independent of its operations (intestinal obstructions caused by swallowing parts of pillows, toys, baskets, etc., gastric torsion, self-inflicted injuries, accidents in the boarding or play areas due to escape attempts or negligence of the animal, etc.).
10. in the event of urgent health issues and my unavailability, I commit to agreeing to the measures deemed appropriate by the trusted veterinarians of the "Rieshof Dogresort". If it is necessary to take the animal to a veterinary clinic, the staff of the boarding facility will arrange for transportation. The veterinary services and care provided by the boarding facility will be charged to me by the owner of the facility upon the pick-up of the animal.
11. the pick-up of the animal will be charged according to the number of nights spent at the facility. If the pick-up does not occur in the morning (refer to opening hours), the owner will be billed for an additional day of stay. An early pick-up will result in the full charge for the reserved period upon drop-off.
12. in the event of a missed pick-up on the agreed-upon date and after a period of 15 days, the "Rieshof Dogresort" is relieved of any responsibility for my animal(s). With the uncollected animal(s), I expressly waive ownership, and therefore, the boarding facility may dispose of the animal(s) as it deems appropriate, including providing them for adoption to third parties. In relation to this, I cannot demand compensation and/or refunds, but it is instead my responsibility to settle the fees for all days that my animal(s) spent in the facility, including those following the missed pick-up, as well as any additional costs and damages.
13. for any disputes related to this contract, the court of Reggio Emilia shall have exclusive jurisdiction.
14. Please note that all personal data will be processed in accordance with the applicable privacy law (D.lgs. 196/2003).
